# Village of Clinton Regular Council Meeting Minutes Of Tuesday, February 20th, 2018

Mayor Knack called the meeting to order on Tuesday, February 20th, 2018 at 7:00 p.m. in the Clinton Village Hall. The Pledge of Allegiance was led by Chief Frey and recited by all those present.

An ice rescue training course had been completed, and a grant application submitted, in amount of \$350,000.00, for purchase of a new tanker.

#### Mayor's Communications:

Mayor Knack and Street Superintendent Seigenthaler had twice met with O.H.M. Advisors regarding the Main Street Culvert Project, set to commence in May and conclude in July of 2018. A project bid conference was scheduled for the 22nd of February.

The Zoning Inspector and potentially Village Solicitor would be intervening to resolve violations in the Main Street vicinity prior to construction beginning. The Council President would no longer be swimming thereabouts.

An application had been sent in to NOPEC, whose policy provided a contribution of up to \$1,000.00 to a local public establishment in exchange for booth space at a community event. The Clinton Historical Society and Applefest, respectively, suited these stipulations.

A news release from Summit County Fiscal Officer Kristen Scalise announced a free delinquent property tax clinic, to be held Thursday March 8th at Odom Boulevard Library.

While the Nexus Gas Transmission Pipeline would not be running through Clinton, its trucks would, and Mayor Knack would attempt to seek recompense for consequential road repairs.
