Regular Council Meeting Minutes

Mayor Knack called the meeting to order on Tuesday, April 16, 2019, at 7:00 p.m. in the Clinton Village Hall. The Pledge of Allegiance was led by Sgt. Kreiner and recited by all those present.

Police Report: March Report | Sergeant Brian Kreiner

Mrs. Gensimore reported on the Community Development meeting that was held prior to the Council Meeting. The main discussion was in regards to the presentation from Charles Drubiel that was given at a prior meeting. There has been some confusion on what was presented in regards to items being able to be picked from or if it was a package deal. She will be getting in touch with Mr. Drubiel to set up a meeting to clarify some of the concerns and then will report back to the committee.

Mrs. Allega reported she is working on a revision with Marshal to current legislation in regards to meetings and the possibility of having to change locations. She will keep everyone informed on the process.

Lewis Rash asked council is they were a sanctuary town. Council responded with no. Lewis then asked if the sheriff's department patrolled through the Village. Mayor Knack said if there was a need for them to be here they would, but there is no contract with them. He also expressed concern over the speed of vehicles coming up and down his road. The Mayor informed him that he relayed his concerns to Sgt. Kreiner.

Diane with the Historical Society asked permission to use Main street Fire Department to host their pancake breakfast on Memorial Day. Mayor Knack approved her request.
